PHILOSOPHY:

The Pat Hall Officials Development Award is designed to promote the development of Vancouver Island umpires and technical officials with preference given to members of the Vancouver Island Ladies Field Hockey Association (VILFHA), the Vancouver Island Field Hockey Association (VIFHA), and the Victoria Junior Field Hockey Association (VJFHA).

DESCRIPTION:

An award up to a maximum of \$500 will be awarded each year. However, if, in any one year, there are multiple candidates accepted, smaller amounts may be considered.

CRITERIA: The applicant must

1. Be member in Good Standing of Field Hockey BC
2. Be an active Official within National, Provincial, or Club based programming

TIMELINES:

The application window will remain open throughout the seasonal year (until such time as the maximum award allotment has been exhausted).
